The bids prepared in accordance with the instructions in the bidding documents with a list of region wise work in hand / progress across all 16 regions of SNGPL, must reach Project Camp Charsadda (Nowshera Road Mohalla Nobahar Tehsil & District Charsadda.). On 03.09.2025 at 11:00 AM (closing time), Bids will be publically opened on the same day at 11:30 AM.



- 4. Technical evolution will be carried out as per criteria (Appendix D & D1) by keeping emphasis on the capabilities / work capacity of the contractor in comparison to their work in hand. If resources are evaluated as not sufficient to undertake further work until completion of already on progress jobs, bid may be rejected.
- 5. It will be responsibility of the bidder to deliver the bids before the closing time. Bids/Quotations received after the bids closing date and time will not be considered and will be returned.
- **6.** Bid Bond Security should be valid for 150 days from date of tender opening from the firms desirous of participating in favor of SNGPL on account of bidding firm while in no case shall be less than 2% of the total amount excluding PST.
