If resources are evaluated as not sufficient to undertake further work until completion of already on progress jobs, bid may be rejected.
5. It will be responsibility of the bidder to deliver the bids before the closing time. Bids/Quotations received after the bids closing date and time will not be considered and will be returned.
6. Bid Bond Security should be valid for 150 days from date of tender opening from the firms desirous of participating in favor of SNGPL on account of bidding firm while in no case shall be less than 2% of the total amount excluding PST.
