

The proprietor of the firms should come to collect the tender documents OR can send a one nominated person of his choice having an authority latter on the original latter head of the firm and requisite CNIC of the proprietor.

The bids prepared in accordance with the instructions in the bidding documents with a list of region wise work in hand / progress of SNGPL, must reach Project Camp Charsadda Mohalla Nobahar, Nowshera road, District Charsadda. On 04.06.2026 at 11:00 AM (closing time), Bids will be publically opened on the same day at 11:30 AM.

4. Technical evolution will be carried out as per criteria (Appendix D & D1) by keeping emphasis on the capabilities / work capacity of the contractor in comparison to their work in hand. If resources are evaluated as not sufficient to undertake further work until completion of already on progress jobs, bid may be rejected.
5. It will be responsibility of the bidder to deliver the bids before the closing time. Bids/Quotations received after the bids closing date and time will not be considered and will be returned.
6. Bid Bond Security should be valid for 150 days from date of tender opening from the firms desirous of participating in favor of SNGPL on account of bidding firm while in no case shall be less than 2% of the total amount excluding PST.
