- Payment:**
All participants' bidders are required to furnish 25% of the bid amount as earnest money along with their sealed bids. The remaining amount shall have to be deposited after approval of bid by competent authority within 15 days by the successful bidder failing which earnest money shall be forfeited. The earnest amount of unsuccessful bidders will be returned on the same day i.e. 26.06.2024.
