- 2. The payment of such Late Delivery Charges shall not relieve the supplier from performing and fulfilling its obligations under the contract nor will the corresponding rights and entitlements of Sui Northern be affected or reduced in any manner.
- Whenever Late Delivery Charges become payable, SNGPL, In its sole discretion shall quantify the same and recover Late Delivery Charges through deduction from outstanding bills of suppliers
 directly by Accounts Department while making payment to suppliers.
- ** The term *Force Majeure* as employed herein shall mean acts of Government in their sovereign capacity, riots, strikes, lock outs, fire occurring in the supplier's establishment, political disturbances, mobilization, wars, unprecedented flood, storms hurricanes or other acts of God.
