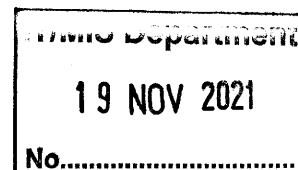

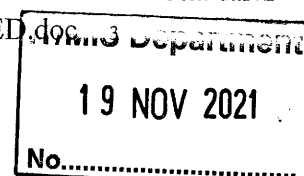

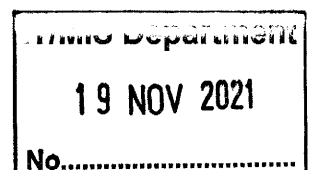
- Shipment is required within 14 weeks after receipt of operative L/C. However, you may quote your best shipment.
- Evaluation will be made on item wise lowest priced bidder basis.**
- Bidders are required to quote their firm unit C&F Karachi prices by sea showing unit FOB cost upto port of shipment and freight separately.
- All the bidders are required **to furnish a bid security of 2%** of the total bid price **(Excluding GST, if offer is on F.O.R basis)** for the offer having value of Rupees One million and above.
- If the offer is on F.O.R. Basis please mention the rates of material/Taxes and duties separately instead of lump sum. In case of non-compliance quoted prices shall be considered inclusive of applicable taxes in material cost.**
- Bids will be evaluated on C&F basis however, order(s) can be placed on FOB (Port of Shipment) or C&F basis.
